# Preface

About global market leaders and top research performance in a prime leisure destination.

The brochure "Tirol – a powerful land" is not an image brochure. Of course, it does also promote our region through attractive pictures. But first of all it presents exciting figures and puts the Alpine country in perspective with the help of these figures.

Many people know our region mainly as a location for tourism. Quite rightly! After all, Tirol registers 44 million overnight stays per year and, therefore, accounts for more than one third of all overnight stays in Austria. But one should also know about the special economic and technological output in Tirol: It is the production of goods that has the highest share in gross value added. Tirolean industry, including global market

leaders like Swarovski, Plansee, Sandoz, Tyrolit and Med-El, generates the third highest export quota of all Austrian Federal States. The research quota of 3.14 percent makes Tirol one of the top four locations for research in Austria.

# Tirol — a powerful land

Tirol is a special location in every respect. Only 11.9 % of the at times alpine land surface is suitable for permanent settlement. Tirol, however, produces an economic output of more than 25 billion euros with about 369,000 people in paid work (self-employed, employed) on a settlement area of only 1,500 km². Internationally, the country is still strongly identified as a tourism stronghold. But there is much more behind the "label Tirol".

For example: excellent research at eight academies and numerous other extramural research facilities; an unparalleled strong landscape of innovation resulting from a technological offensive which has been initiated by political measures; a close network of dynamic small and medium-sized companies which successfully work in future-oriented business sectors such as life sciences, medical engineering, renewable energies, IT or mechatronics; and a very ambitious cluster scene that helped to achieve an impressive collaboration performance.

The Tirolean location development is convinced that full force needs strong teams. The available data confirm this approach and are also the basis of the strategic decision to link Tirolean know-how in the sectors of health, technology and tourism even more closely in the future. The vision behind this approach? Tirol will become a "smart region" and the most demanded location in the Alpine world.



### Population growth

Since 2000 the population of Tirol has increased by 8.4 %, to a current level of almost 728,500 people.

### Overall population proportion

Tirol represents 8.5 % of the population of Austria.


### Demographic change

One major challenge for Tirol as an economic location is the demographic change. Over the next 25 years the number of people younger than 65 years will shrink from the present 452,481 people to 442,732.


Austria as a whole 2014: 8,579,378

### Tirol's share of the total population of Austria, as a percentage (2014)


Tirol represents 8.5 % of the population of Austria

### Increases in population 2000 - 2014 in percent


The population of Tirol has grown by 8.4 % since 2000

### Development in employment

The past few years have seen constant growth in employment in Tirol. One exception was the year 2009, when the financial crisis caused a (slight) reduction in employment during the year.

### Growth in employment

There were a number of factors with regard to offers and availability which were responsible for the growth in employment. On the one hand, there was the (still) increasing number of persons of employable age (15 – 60 age group), as well as the increase in the employment of women, and the increase in part-time work.

### Making the labour market more flexible

With regard to demand, over the past few years both the economy in general and the public sector have been creating more jobs, and, at the same time, making them more flexible.


### Unemployment rate

On an annual comparison, the unemployment rate in Tirol is consistently and clearly below the average for Austria as a whole. A determinant factor in this is, among others, the higher intensity of employment in the service sector (in particular in tourism).


Austria as a whole 2014: 4,112,900



# Economic performance

### GDP per inhabitant

It is the Gross Domestic Product (GDP) per inhabitant which serves as the recognized yardstick for the economic performance of a region. In 2013, the GDP per inhabitant in Tirol stood at 40,000 €, which sets it above the average for Austria, at 38,100 €.

### Tirol in a Europe-wide comparison

A comparison of the GDP per inhabitant in the 280 regions of the European Union (referred to as NUTS-2 Regions) shows clear differences: The highest per capita Gross


Domestic Product is achieved by the Region of Inner London (85,500 € or 337 % of the average), followed by Luxemburg (69,800 €), Brussels (55,500 €) and Hamburg (52,100 €).

In a comparison of all the European regions, Tirol holds place 31. Last in the table are the Bulgarian regions of Severozapaden (7,400  $\in$  or 29 % of the average) and Severen Tsentralen (8,200  $\in$  or 32.3 % of the average).


### Nominal economic performance by Austrian Federal Provinces, in millions of €

# **Export**

### Tirol - An Export Economy


Tirol has a small and open regional economy. That means the economic performance of the region is heavily characterized by export business. In 2014, the Tirolean economy exported goods to the value of 11.2 billion euros – a new record.

### Growth in exports

Since joining the European Union in 1995 Tirolean exports have more than tripled; from three billion euros to 11.2 billion euros. In 2014 28 % of the Tirolean exports went to Germany, 17 % to Switzerland/Liechtenstein and 10 % to Italy. In recent years the US American market has gained in importance: by now 5 % of the Tirolean exports go to the USA (about 600 million euros)

# Value creation

### Regional distribution and trends

42 % of the gross regional product of Tirol is generated in the "central" areas of Innsbruck City and Innsbruck Land, with the importance of the area of Innsbruck Land increasing for a number of years.

In the areas of Landeck and Kitzbühel the tourist economy predominates.

### Value added structure


40 % of Tirol's value added derives from the tertiary sector; the productive sector accounts for 28 % and the public sector for 16 %. As to the Austrian average, Tirol's tertiary sector is very strong. The Austrian average for the tertiary sector amounts to about 36 % of the total value added. The accommodation and catering sector are especially dominant in Tirol (14 % of the gross value). In 2012 the total gross value of Tirol amounted to 25 billion euros.

### Gross fixed capital formation

In 2012 gross fixed capital formation in Tirol accounted for around 6.7 billion euros. The real estate sector invested some 2.1 billion euros; the material goods production invested around 1.1 billion euros, accommodation and catering invested about 370 million euros.


### Value creation in Tirol by economic sectors in percent (2012)

Around 42 % of value creation is generated in the "Central Innsbruck" area



Tirolean economy has successfully overcome the international crisis.



With an established production of more than 9.5 billion euros, industry is a major pillar of support for Tirol as an economic region.


### **Export of Tirolean industrial products**


Around 58 % of Tirol's industrial production is exported, representing goods to the value of 5.7 billion euros.

For some years now, Tirol has held third place in industrial exports among all of Austrian Federal Provinces, following Vorarlberg and Styria (Vorarlberg export quota: 79.2 % and Styria 70.2 %).

In 2014 Tirol's industry generated more than 9.5 billion euros



# Commercial concerns

### Sector mix

Tirol's commercial sector is dominated by small and very small businesses, and characterized by a balanced sector mix. 38 % of the businesses are engaged in the trade and crafts sector (16,151), followed by the industry branch with 9,069 and tourism with 8,460 enterprises respectively.

### Medium-sized and large businesses


Only 1.5 % of the 42,453 businesses are medium-sized and large businesses (more than 50 employees). These, however, account for 50 % of the 232,891 wage earners employed in the industry.


Active members of Chambers of Commerce as at 31st December, 2014 in Austria: 479,338


# Establishment of companies

### Entrepreneurial spirit on the rise

Since the mid-1990's, an increasing number of new businesses has been established in Tirol. This is associated in particular with the structural change taking place in the commercial sector, such as the greater number of single-person businesses and service sector companies.

Tirol demonstrates dynamic development in the establishment of businesses



Tirol can truly claim to be a stronghold of tourism. No other Austrian Province records so many guest overnight stays as Tirol.

### Value creation from tourism

Tourism is a central pillar supporting the value creation chain of Tirol, and has helped many of the isolated valleys of the region to enjoy prosperity and gain an excellent infrastructure.


Tourism is also an important client for other sectors of the economy, such as construction and material goods production.

### Tourism means stability

As well as this, tourism has repeatedly proved in the past to be an important "economic airbag", providing stabilization even in difficult economic times, in particular with regard to the labour market.

# Overall economic significance and integration of tourism in Tirol





## Gross value added of tourism in Tirol (Tourism Satellite Account)

Gross value added of 4.5 billion euros results from the overall turnover of about 8.4 billion euros generated in the Tirolean tourism sector in 2014 (this not only includes overnight stays but also turnovers from museum admissions, shopping, transport, etc.) with an average

value added quota of 53.3 %. The tourism share in Tirol's total gross value added of 25.6 billion euros (2013) amounts to 17.6 % (2003: 15.4 %).


By way of comparison: in 2013 Austria's direct tourism gross value added totaled 18.2 billion euros, or 6.3 % of the overall gross value added.

### Ranking of the Austrian Federal Provinces by numbers of guest overnight stays in 2014


Tirol tourism Number One in an all-Austria comparison


### Overnight stays in Tirol since 1992

Over 44 million guest overnight stays in Tirol in 2014




### Top 10 source markets by overnight stays in winter 2014/15

### Research and development rate

Tirol's R&D rate of 3.14 % of the GDP ranks among the top Austrian locations for research and technology.

### Research expenditure

Tirol ranks second in accumulated growth in an Austria-wide comparison of the entire gross domestic expenditures on R&D from 2002 – 2013. Tirol's expenditures on R&D increased within this period of time by 168 %. Tirol ranks third in an Austria-wide comparison of the entire gross domestic expenditures on R&D per capita with 1,265 euros. The Republic of Austria invests 379 euros per capita in Tirolean research, which makes Tirol the second strongest of the provinces.

### Tirol - Location for research

Basic research (23.6 % of the Tirolean R&D expenditures; second in an Austria-wide comparison) and very strong applied research (41.5 % of the Tirolean R&D expenditures) make Tirol such a successful centre for technological innovation. Tirol's strong position regarding applied research results from the close collaboration of businesses and science centres as well as of innovative enterprises and R&D institutions organized in six clusters. 34.9 % of Tirol's R&D expenditures (the lowest amount of all Austrian provinces) accounts for experimental development.


### **Protagonists**

Tirol is home to three universities, 38 university hospitals, two universities of applied science, Management Centre Innsbruck, two colleges of education, five non-university R&D institutions, four Christian Doppler laboratories and 25 multi-year research collaborations of economy and research, COMET and K-Regio – competence centres of the state and of the province respectively. Tirol counted 5,472.5 people employed (full time equivalents) in research and development, 61 % are working for businesses.

### Regional research rate - development 2007-2013 in national comparison






### Gross domestic expenditure on R&D per capita - development 2009 - 2013 in national comparison

### Tirolean academies and students

More than 47,000 students in Tirol

Innsbruck, the capital of Tirol, is a major university town. Leopold Franzens University was already established in 1669 and is now the biggest and most important West Austrian research and educational institution with about 28,000 students and more than 4,500 employees.

The Medical school spun off in 2004 and has since then been established as independent Medical University of Innsbruck.

Tirol is home to eight academies and other renowned institutions such as UMIT, MCI or Kufstein University of Applied Sciences. Universities and technical colleges are very important research partners of the Tirolean economy. They are also a substantial economic factor educating and providing highly trained professionals for the domestic economy.

### Tirol – strong in renewable energies

Presently, Tirol covers 41 % of its total energy demand with own resources, two thirds thereof are from hydraulic power and one third from other renewable energy sources (biomass, biogas, solar energy and environmental heat).

### Tirol 2050 – energy-autonomous


By 2050, the entire energy demand shall be covered by local renewable resources. The development potential of water supply will be made accessible through specific regional programmes. At the same time, generation of electricity from photovoltaics will increase significantly and geothermal heat, solar heat and biomass will gain in importance.

### Low industry electricity price

The local industry profits from the comparatively low electricity prices and enjoys a decisive competitive advantage.

The future of Tirol energy


