- 10 or fewer employees
- Developing therapeutics or diagnostics for which the young company owns the intellectual property; or owing the IP for a platform technology used for drug design or discovery

Rates and deadlines:

- **Apply until 31.01.2025: € 795** (excl. VAT)
- **Apply until 28.02.2025: € 995** (excl. VAT)
- **Apply until 14.03.2025: € 1,195** (excl. VAT)

The conference organizers will vet your request and you will be notified of the decision within five working days after submission of your request. If you qualify for this offer, you will receive confirmation and a **VIP code to register at the discounted rate directly with the conference organizers**. You don't have to fill in the LISA form.
